Reggio Emilia, 12 October 2020 – Iren, following the announcement in 12 May 2020 concerning the launch of share buy-back program authorized by the Shareholders' meeting of 29 April 2020, announces that has purchased, in the week from October 5 to October 9, 2020, no. 494,614 of its own shares at an average price per share equal to Euro 2.1516, for an aggregate amount of Euro 1,064,200.33.
