Reggio Emilia, 18 January 2021 – Iren, following the announcement in 20 November 2020 concerning the launch of share buy-back program authorized by the Shareholders' meeting of 29 April 2020, announces that, in the week from January 11 to January 15, 2021, Goldman Sachs, as the authorized intermediary on behalf of Iren S.p.A., did not carry out any stock purchase transactions.

As of January 15, 2021 the Company holds 15,868,004 treasury shares, equal to 1.2197% of the share capital.
