

Report on treasury shares purchase program

Reggio Emilia, 5 July 2021 – Iren, following the announcement in 20 November 2020 concerning the launch of share buy-back program authorized by the Shareholders' meeting of 29 April 2020, announces that, in the week from June 28 to July 2, 2021, Goldman Sachs, as the authorized intermediary on behalf of Iren S.p.A., did not carry out any stock purchase transactions.

As of July 2, 2021 the Company holds 17,855,645 treasury shares, equal to 1.3725% of the share capital.
