Reggio Emilia, 1 March 2021 – Iren, following the announcement in 20 November 2020 concerning the launch of share buy-back program authorized by the Shareholders' meeting of 29 April 2020, announces that has purchased, in the week from February 22 to February 26, 2021, no. 481,029 of its own shares at an average price per share equal to Euro 2.0711, for an aggregate amount of Euro 996,239.30.
