

Report on treasury shares purchase program

Reggio Emilia, 1 July 2019 – Iren, following the announcement on 13 May 2019 concerning the launch of the share buyback program authorized by the Shareholder meeting of 5 April 2019, announces that has purchased, in the period from 24 to 28 June 2019, no. 192,202 of its treasury shares at an average price per share equal to 2.2526 euro, for an aggregate amount of 432,946.35 Euro.

On the basis of information provided by Goldman Sachs, the intermediary appointed for the repurchase of the shares, the details of the purchases of treasury shares on a daily basis and in aggregate form, are reported below:
