

Report on treasury shares purchase program

Reggio Emilia, 12 August 2019 – Iren, following the announcement on 13 May 2019 concerning the launch of the share buyback program authorized by the Shareholder meeting of 5 April 2019, announces that has purchased, in the period from 5 August to 9 August 2019, no. 25,433 of its treasury shares at an average price per share equal to 2.3974 euro, for an aggregate amount of 60,973.07 Euro.
