

**Report on treasury shares purchase program***Period 1 March 2021 – 5 March 2021*

Reggio Emilia, 8 March 2021 – Iren, following the announcement in 20 November 2020 concerning the launch of share buy-back program authorized by the Shareholders' meeting of 29 April 2020, announces that has purchased, in the week from March 1 to March 5, 2021, no. 364,696 of its own shares at an average price per share equal to Euro 2.0492, for an aggregate amount of Euro 747,324.50.
